

CEDAR COVID Protocol

1. Families will have the option of attending classes virtually or in person. Once a decision is made for attendance, students will need to continue in that means during the duration of the semester. There will be exceptions in that if a family feels it best to move to the virtual learning platform the student may do so during the semester, however, students may not change from virtual to live classes.
2. Classrooms will be enhanced for remote teaching and learning.
3. Each student that attends CEDAR for live classes will need to have a signed consent/release from responsibility form on file for admittance into the building. This form will need to be downloaded and filled out before you come to the first day of class. If a student arrives on campus without the release they will not be allowed into the building.

4. **Admittance-**

Scans and entrances will begin at 7:30 each morning. Parents will need to form a car line and students will be waved over for scanning one at a time. Parents will not be able to leave the car line until the student has cleared the wellness check in. If the student's temperature is above 99.5 they will not be admitted that day. If during the day a student begins to show any signs of illness- fever/chills, headache, shortness of breath/difficulty breathing, fatigue, muscle or body aches, sore throat, congestion or runny nose, nausea/vomiting, diarrhea, cough, new loss of taste or smell- they will be isolated and the parent will need to come pick up the student in a timely manner.

Students who drive themselves to campus will need to line up staggered single file to the south entrance and will be scanned interspersed with the auto traffic for admittance.

Cedar5 students will begin entrance scanning at 8:05 each morning.

5. **Masks/Facial Coverings-** Masks are required at all times except when eating lunch. Face coverings must be worn while students are both indoors and out, walking from the car to the building, in classrooms, common areas, hallways and all other areas of CEDAR. Masks may only be removed for eating lunch.

6. **Lunch-**

The lunch break time will remain from 12:15-12:35.

Each student must bring a cooler bag with his or her lunch. There will be NO refrigerator OR microwave option for keeping lunch cool or warming lunch up.

After lunch is finished the student will be responsible for thoroughly wiping down their area that they sat in.

7. **Cleaning-** Each student will be responsible for providing antibacterial wipes that they will carry with them in their backpacks. Students will wipe their areas down (tops, bottoms, seats) when they arrive in a class and before they depart and in any area that they might study or have lunch. Instructors will allow time in the class for this to happen. Students also need to carry antibacterial hand sanitizer with them to use often during the day.

8. **Bathrooms-**

ONLY the front bathrooms will be open for use. Bathrooms in back hallway near science room will not be used. These will be cleaned throughout the day.

No more than 2 students will be allowed in the bathroom at the same time. Each student will need to make sure that they wash their hands for 20 seconds after they have used the restroom.

9. **Water fountains-** there will be NO fountains accessible to the students. It is encouraged that the student brings with them water that they will need for the day. You may choose to pack an extra bottle in your cooler.
10. No parent is to be in the building unless they are helping with direct facilitation of a class. Parents that need to be in the building must also fill out a waiver releasing responsibility/ wellness check and have their temperature taken. Parents with these responsibilities must wear masks in the building as well.
11. Students will enter from the south entrance and exit the building from the north entrance.
12. If a student is believed to have been exposed, even if they are not showing symptoms, is requested to remain at home and virtually participate in class for at least 14 days, or until they have a negative test result. If a student tests positive they will need to remain home and virtually attend classes the remainder of the semester.
13. If a teacher or the class is exposed that class and all of the other classes that the teacher is teaching will be moved to the virtual platform for 14 days. If the teacher tests positive the classes will be virtual the remainder of the semester.

If a teacher does present with a fever for daily check in those classes will be canceled or postponed for the day.

14. Moving around the building. All movement around the building must be done single file, practicing the 6 feet of distance. Halls will either be marked as to which side movement will happen or they will be one way.
15. Classrooms will be set up so that there is physical distancing between students.
16. Study Hall- Study Hall will remain the same with social distancing and no movement around the room.
